- 1 Under the terms of Career Statutes For Teaching Staff in Polytechnic Higher Education (ECPDESP), approved by Decree-Law no. 185/81, of July 1, amended by Decree-Laws no. 69/88, of March 3 and 207/2009, of August 31, and by Law no. 7/2010, of May 13, and in accordance with the Regulation of Recruitment and Hiring of Career Teaching Staff of the Polytechnic Institute of Leiria (Polytechnic of Leiria), published in the *Diário da República*, 2nd series, no. 127, of July 2, 2010, through Order no. 10990/2010, it is made public that, by order of November 10, 2020, issued by the President of the Polytechnic of Leiria, on the proposal of the Director of the School of Education and Social Sciences of Leiria (ESECS), a competition for the recruitment of a Senior Lecturer is open for a period of thirty working days, from the date of publication of this Public Notice in the *Diário da República*, in the form of a contract of employment in public functions for an indefinite period of time for the subject area of Sociology disciplinary area of Inequalities and Public Policies, at the School of Education and Social Sciences of Leiria of Polytechnic of Leiria 1 vacancy:
- 2 Validity period: this competition is exclusively for the filling of the above mentioned vacancy, and will finish when the respective admission is complete.
- 3 Functional content of the category:
- 3.1 It is the responsibility, namely, of the teachers of polytechnic higher education, pursuant to article 2-A of the ECPDESP, to provide the teaching service that is assigned to them and to accompany and guide the students; to conduct research activities of cultural creation or of experimental development; to participate in tasks of development, scientific and technological dissemination and appreciation of economic and social knowledge; and to participate in the management of the respective institutions of higher education.
- 3.2 Within the terms of no. 4 of article 3 of ECPDESP, the Senior Lecturer is responsible for collaborating with coordinating professors within the scope of a subject or scientific area and, in particular to: conduct and teach theoretical, theoretical-practical and practical classes; supervise, guide and monitor internships, seminars and laboratory or field work; manage, develop and carry out scientific research and experimental development activities, in accordance with the general lines previously laid down by superiors within the scope of the respective subject or scientific area; cooperate with other professors of the subject or scientific area in the coordination of programmes, teaching methodologies and general lines of research with regard to the subjects of that area.

- 4 Remunerative position (article 35, no.1, ECPDESP): "The remuneration system applicable to career teachers and other teaching staff is defined in a separate law"— Decree-Law no. 408/89, November 18, amended by Decree-Law no. 76/96, June 18, and Decree-Law no. 124/99, April 20 and Decree-Law no. 373/99, September 18.
- 5 Admission requirements:
- 5.1 Under the terms of article 17 of the General Labour Law on Public Service, approved by Law no. 35/2014, of June 20, in its current wording and of article 12-E of the ECPDESP, only candidates who, up to the date limit for submitting applications, meet all of the following general requirements may apply:
- a) Be over the age of 18;
- b) Not be inhibited from carrying out public service nor be forbidden to carry out the functions to which they are applying;
- c) Have physical robustness and the psychological profile required to carry out the functions to which they are applying;
- d) Have complied with the mandatory vaccination laws.
- 5.2 In compliance with article no.17 of ECPDESP, those who hold a doctoral degree or the title of specialist in the area or an area related may apply. The title of specialist mentioned in article 17 of the ECPDESP refers to the provision of article 48 of Law no. 62/2007, of September 10 and of Decree-Law no. 206/2009, of August 31.
- 5.3 Candidates holding foreign qualifications must prove the recognition, equivalence or registration of the doctoral degree, pursuant to applicable legislation.
- 5.3.1 Under article 25 of Decree-Law No. 66/2018 of August 16, which approved the legal regime for recognition of academic degrees and higher education diplomas attributed by foreign higher education institutions, applicants are exempt from providing proof of recognition or equivalence of the foreign degree or diploma at the application phase.
- 5.3.2 The recognition or equivalence of the foreign degree or diploma, not presented in the application phase, will take place in the contractual phase, within the time limit set by the human resources services of the Polytechnic of Leiria. Failure to provide proof within the defined time limit precludes the conclusion of the respective employment contract in public functions, pursuant to article 33 of the Recruitment and Hiring Regulation of the Career Teaching Staff of the Polytechnic of Leiria.
- 6. Application procedure:

- 6.1 Applications must be presented personally, in which case a receipt will be given, or by registered post with acknowledgement of receipt, sent to the following postal address of IPLeiria: Rua General Norton de Matos, Apartado 4133, 2411 901 Leiria, up to the limit date set for applications as specified in no.1 of this Public Notice.
- 6.2 Applications must be presented with a competition admission request, using the Polytechnic of form available on the Leiria website (http://www.politecnicodeleiria.pt/recursos-humanos/concursos/) addressed President of the Polytechnic of Leiria, dated, signed and initialled (which must include: full name, date of birth, sex, nationality, civil identification number, postal and electronic addresses, telephone number, academic qualifications, professional category and position currently held (if applicable), indication of the competition being applied for, Public Notice number, with mention of the Diário da República in which it was published, as well as a list of the documents accompanying the application).
- 6.3 Candidates must accompany the application with the following documents, duly numbered and identified:
- a) Photocopy of the certificate of academic and professional qualification or other document legally recognized for the purpose;
- b) Declaration of honour, to be given in the form referred to in point 6.2 of this public notice, on the status regarding each of the subparagraphs a), b), c) and d) of section 5.1 of the public notice;
- c) Documents attesting that the candidate meets the legal conditions referred to in no. 5.2 of this public notice;
- d) 1 copy of the curriculum vitæ, duly dated and signed, mandatorily organized in accordance with the selection and seriation criteria and assessment and final classification system as laid out in no. 7 of this public notice;
- e) 1 copy of the documents proving the facts stated in the curriculum;
- f) 1 Copy of the work plan and scientific development in line with the mission of the School of Education and Social Sciences of the Polytechnic of Leiria and the Interdisciplinary Centre of Social Sciences (CICS. NOVA Polytechnic of Leiria hub) for the next six years;
- g) List in non-editable format containing the exact identification of all submitted documents (index or list with the name of each document in the order in which they are presented).

- 6.4 The elements referred to in point 6.3 will necessarily be delivered in a single non-editable file (pdf) in digital format (CD/DVD/PEN/) duly identified.
- 6.5 —The documents referred to in the previous point must, as a rule, be in the Portable Document Format (PDF), preferably in the PDF/A version, except in situations where the document to be presented cannot assume the indicated format; the file name, which must be succinct, cannot contain any of the following characters: /, \, |,:, *,?, ", (less than), and (greater than).
- 6.6 The documents can be presented in Portuguese, Spanish or English. When documents proving the facts indicated in the curriculum or works mentioned in the curriculum are originally written in another language, a translation into Portuguese, Spanish or English must be provided simultaneously.
- 6.7 The non-presentation of the supporting documents proving the requirements of points 5.1, 5.2, and 5.3 in this public notice or its presentation after the time period stipulated in no.1 of this public notice will lead to the exclusion of the application.
- 6.8 Failure to present the documents related to the curriculum presented by the candidate implies the non-valuation of the elements that should prove.
- 6.9 The presentation of false documents will lead to immediate exclusion from the competition and reporting of the fact to the competent authority for purposes of criminal prosecution.
- 6.10 The documents provided by candidates can be returned upon request, one year after the conclusion of this competition, except in the event that this competition has been subject of judicial impugnation. In this case the return of documents may only take place after the jurisdictional decision has become final.
- 7 Selection and seriation criteria and assessment and final classification system (stipulated in accordance with the terms of articles 11, paragraph 2, subparagraph (a) and 18, paragraph 1, subparagraph (l) and (m) and paragraph 2 and 3 of Official Order No. 10 990/2010):
- 7.1 Technical-scientific and professional performance (DTCP) in which the following items should be considered:
 - a) The participation in research and development projects (PID);
 - b) The scientific production, publications, communications and conferences at home and abroad (PC);
 - c) The supervision of works leading to the achievement of academic degree (OT);
 - d) Participation in juries of academic examinations (JPA);

- e) Integrated Researcher of Research Unit positively assessed by FCT (II);
- f) The participation in professional training activities and in committees of scientific societies and scientific conferences considered relevant in the competition's area (FPSC).
- g) Work plan and scientific development aligned to the mission of the School of Education and Social Sciences of the Polytechnic of Leiria and the Interdisciplinary Centre of Social Sciences (CICS. NOVA Polytechnic of Leiria hub) for the next 6 years (PTDC);
- 7.1.1 The classification to be awarded in this criterion, which represents 45% of the final classification, to a maximum of 100 points, results from the application of the following formula: DTC = (PID + PC + OT + JPA + II + FPSC + PTDC), being the above items assessed as follows:
- a) PID: active participation in research and development projects, in the disciplinary area of the competition, is valued with a maximum value of 10 points and the valuation is made in the following terms:
 - i) For each coordination in funded research project 5 points;
 - ii) For each participation in funded research project -2.5 points;
 - iii) For each coordination in not funded research project 1 point;
 - iv) For each participation in not funded research project -0.5 points;
- b) PC: the scientific production and its sharing with the scientific community, in the disciplinary area of the contest, is valued, with a maximum value of 45 points, and the valuation is made in the following terms:
 - i) Scientific book publication in authorship or co-authorship 6 points;
 - ii) Scientific book publication as editor or co-editor 4 points;
 - iii) For each publication of book chapters 2 points;
 - iv) For each scientific article published in a scientific journal with peer review indexed in SCOPUS or Web of Science 4 points;
 - v) For each scientific article published in other scientific journal (national or international) with peer review 2 points;
 - vi) For each oral communication presented at a national conference, scientific meeting or seminar, published in the respective minutes 1 points;

- vii) For each oral communication presented at an international conference, scientific meeting or seminar, published in the respective minutes 2 points;
- viii) Publication of a scientific report or working paper in authorship or co-authorship 1 point;
- ix) Other scientific outputs considered as relevant -0.5 points
- c) OT: the supervision or co-supervision of doctoral theses, dissertations, projects and final master reports is valued with a maximum value of 10 points and the valuation is made in the following terms:
 - i) For each supervision or co-supervision of doctoral theses already completed 5 points;
 - ii) For each supervision or co-supervision of dissertations, projects and final master reports already completed 2 points;
- d) JPA: the participation in juries of academic examinations as examiner is valued with a maximum value of 10 points and the valuation is made in the following terms:
 - i) For each participation in doctoral juries: 5 points;
 - ii) For each participation in master's or specialist title juries: 2 points;
- e) II: Integrated researcher of Research Unit rated at least with Good by FCT 10 points:
- f) FPSC: the activities mentioned above are valued with a maximum value of 5 points and the valuation is made in the following terms:
 - i) For each organisation of professional training activities properly accredited or certified 2,5 points;
 - ii) For each integration in scientific committee of conferences/events of scientific societies or organizations, in the competition's area (CC) 2.5 points.
- g) PTDC: the following contributions are valued in line with the mission of the School of Education and Social Sciences of the Polytechnic of Leiria and the Interdisciplinary Centre of Social Sciences (CICS.NOVA Polytechnic of Leiria hub) for the next 6 years, with a maximum value of 15 points:

- i) Contribution to the fulfilment of the institution's mission regarding teaching development in the contest's disciplinary area, including international dimension - 5 points;
- ii) Contribution to the fulfilment of the institution's mission regarding research development, including international dimension 5 points.

7.2 - Candidate's pedagogic ability (CP), in which are considered:

- a) Teaching activity. Teaching and coordination of curricular units in the competition's area (AL);
- b) Production of teaching material. Quality and quantity of teaching material produced by the candidate in the competition's area (MP);
- c) Coordination and promotion of new pedagogical projects (e.g. development of new programs of curricular units, creation and coordination of new study programs, etc.) or reform and improvement of existing projects (e.g. reformulating existing curricular unit programs, participating in the reorganization of existing courses or study programs), as well as carrying out projects with an impact on the teaching/learning process in the competition's area (CPP);
- d) Supervision of curricular internships in the scope of undergraduate or master's degree in the competition's area (SE).
- 7.2.1 The classification to be awarded to this criteria, which represents 45% of the final classification, to a maximum of 100 points, results from the application of the following formula: CP = (AL + MP + CPP + SE), being the above items assessed as follows)
- a) AL: the activities mentioned below are valued with a maximum value of 35 points and the valuation is made in the following terms:
 - i) Professional experience and dedication to teaching in higher education (full years of full-time teaching service) 4 points for each school year;
 - ii) Professional experience and dedication to teaching in higher education (full years of part-time teaching 3 points for each school year;
 - iii) For each coordination of curricular unit in the area for which the competition is opened 3 points.
 - iv) For each curricular unit lectured in the area for which the competition is opened 2 points.

- b) MP: the quality and quantity of pedagogical material produced is valued, with a maximum value of 15 points, and the valuation is made as follows:
 - i) For each pedagogical material related to curricular units in the area for which the competition is opened, which evidences current information -1 point.
- c) CPP: the following activities are valued, with a maximum value of 20 points, and the valuation is made as follows:
 - a) For each coordination and promotion of new pedagogical projects (e.g. development of new courses and respective curricular unit programs) 2,5 points.
- d) SE: the coordination or supervision of internships is valued with a maximum value of 30 points and the valuation is made in the following terms:
 - i) For each supervision of curricular internships in undergraduate courses in the area for which the competition is open- 2,5 points.
- 7.3 Other activities relevant to the mission of the higher education institution which have been developed by the candidates (AR), in which are considered:
 - i) Exercise of executive positions in management bodies and the participation in bodies or structures of higher education institutions (ECOEI);
 - ii) Participation in scientific networks, associations or societies, within the competition's area (RSC).
- 7.3.1 The classification attributed in this criterion represents 10% of the final classification, to a maximum of 100 points, and results from the application of the following formula: AR = (ECODEI + RSC) being the above items assessed as follows:
- a) ECOEI: the above activities are valued with a maximum value of 40 points and the valuation is made in the following terms:
 - i) For each year of mandate fulfilled as a member in bodies of the institution or of organic or research units of the higher education institution: 5 points;
 - ii) For each year of exercise fulfilled in the institution's structures, such as scientific and pedagogical committees of higher education courses in the competition area 5 points.

b) RSC: the participation in scientific networks, associations or societies is valued, with a maximum value of 60 points:

i) For each year of participation in scientific networks, associations or societies - 5

points.

7.4 - The final classification (CF), on a scale from 0 to 100 points, will be obtained by the

following formula: CF = (0.45 DTC + 0.45 CP + 0.10 AR), considering as not approved

the candidates who obtain a final classification lower than 50 points and approved in

absolute merit the candidates who obtain a final classification equal to or higher than 50

points.

7.5 – The ranking of candidates for the competition will be based on the scientific and

pedagogical merit evidenced by the candidates in the disciplinary area of the competition,

with special emphasis on items in the field of Inequalities and Public Policies.

7.6 — In the reasoned assessment the jury must also take into account the provisions of

article 26 of Order no. 10 990/2010, if the candidates are in the conditions referred to in

that article

7.7 – In case of a tie between candidates, after obtaining the final classification, the

following tiebreaker criterion shall be applied:

1st - Best score obtained in the criterion: DTC (Technical-Scientific and professional

performance);

2nd - Best score obtained in the criterion: CP (Candidate's pedagogic ability).

8 - Public Hearing: The Jury may determine the holding of public hearings, which will be

attended in accordance with Article 28, paragraph 4 of Official Order No.10990/2010. If

these public hearings are required, they will take place between the 20th and 70th days

following the deadline for submission of applications, and all applicants will be informed

at least five days in advance of the date and place where these public hearings will take

place.
