

The Polytechnic Institute of Leiria (IPLeiria), through its Institute for Research, Development and Advanced Studies (INDEA), within the Marine and Environmental Sciences Centre (MARE-IPLeiria), is accepting applications for a postdoctoral grant (BPD), in the following terms:

**Project title:** SmartBioR – Smart Valorization of Endogenous Marine Biological Resources Under a Changing Climate (CENTRO-01-0145-FEDER-000018).

**Project coordinator (IPLeiria):** Marco Filipe Loureiro Lemos.

**Grant scientific coordinators:** Marco Filipe Loureiro Lemos and Susana Luísa da Custódia Machado Mendes.

**Grant scientific area:** Science and Technology Management.

**Grant type:** Science and Technology Management Grant (BGCT).

**Goals:** To contribute for outreach activities of the project; to contribute for outreach activities of MARE-IPLeiria; and to seek funding opportunities and support project applications.

**Object:** To ensure project management.

**Grand duration:** 12 months, eventually renewable until the end of the project, with expected start on June 2018.

**Goals to be achieved by the candidate:** Daily management of SmartBioR project, securing its milestones, deliverables and reports; Contribute for outreach activities and project internal and external communication; Support in MARE-IPLeiria science management and communication; Explore and apply for funding opportunities.

**Recipients:** Holders of a doctoral degree in Biological Sciences, Marine Sciences, Food Sciences or Science and Technology Management.

**Desired profile:** We look for a candidate with experience in science and technology management, preferably with proven working knowledge of European and national research structures, funding programmes and project proposals submission and management. Experience in dissemination and science communication, website management, and project calls application and knowledge will be highly considered. Portuguese language native level and excellent domain of the English language skills are mandatory. A recent doctoral degree will be preferred, and a strong motivation, autonomy and teamwork spirit soft skills are also regarded.

**Work place:** CETEMARES and School of Tourism and Maritime Technology (ESTM-Leiria), city of Peniche, Portugal.

**Financing entity:** Co-funded by CENTRO 2020 program, PORTUGAL 2020, European Union, through the European Regional Development Fund.

**Grant financial components:** Monthly maintenance allowance of €1495,00, per the Research Grants Regulation from FCT, I. P. ([www.fct.pt/apoios/bolsas/valores](http://www.fct.pt/apoios/bolsas/valores)) and the Scientific Research Grants Regulation from IPLeiria. To this allowance is added the monthly value of Voluntary Social Security, under the conditions defined by the Statute of the Research Fellow and if the fellow chooses to join this scheme, as well as the Personal Accident Insurance, in force during the grant.

**Periodicity:** Monthly.

**Payment method:** Check or bank transfer.

**Activity mode:** Exclusivity, according to the applicable legislation.

**Applications evaluation:** The applications evaluation is based on the curriculum vitae analysis and eventual interview, according to the desired profile and the evaluation criteria.

**Evaluation criteria:** Curriculum Vitae evaluation (CV) followed by an interview (INT) of the selected candidates, with the final score (FS) being set as  $FS = CV \cdot 0,7 + INT \cdot 0,3$ . A minimum score in the CV evaluation criteria is set (corresponding to 50% of the total possible score) to be eligible for the interview. The evaluation and ranking criteria are part of the minute created by the jury, which can be consulted upon request by the interested parties.

**Jury:** The jury in charge of the applications evaluation is constituted by the following Doctors: Susana Luísa da Custódia Machado Mendes (president), Marco Filipe Loureiro Lemos and Maria Manuel Gil de Figueiredo Leitão Silva (effective members); Maria Jorge Gerales Campos and Carla Sofia Ramos Tecelão (substitute members).

**Grant renewal:** According to the 27<sup>th</sup> article from the Scientific Research Grants Regulation from IPLeiria.

**Applications deadline:** From 10<sup>th</sup> to 24<sup>th</sup> of May, 2018.

**Formal application:**

Through the application form, correctly filled and signed, available in [www.ipleiria.pt](http://www.ipleiria.pt), accompanied by the following documentation:

a) Documents proving that the candidate gathers the required conditions for the type of grant, namely certificates of qualification with final average and with classifications in all the disciplines realized. Candidates holding foreign qualifications must prove the registration of the academic degree, in accordance with Decree-Law no. 341/2007, from October 12, or, when applicable, obtaining equivalence / recognition of the academic degree, in Decree-Law no. 283/83, from June 21;

b) Curriculum Vitae of the candidate;

c) Valid civil identification number;

d) Declaration on the application form which does not simultaneously benefit from any other grant for the same purpose or, if so, that there is an agreement between the financing entities;

e) Any other document, which the candidate considers relevant for the application evaluation.

**Submission of applications:** The applications can be delivered personally at ESTM-Leiria; or sent to Escola Superior de Turismo e Tecnologia do Mar – Campus 4, Santuário Nossa Senhora dos Remédios, 2520-641 Peniche (in registered mail with reception notification, sent until the specified deadline); or sent by e-mail to [susana.mendes@ipleiria.pt](mailto:susana.mendes@ipleiria.pt).

**Disclosure of the results:** Up to 10 working days after the selection ends, through an e-mail with reception receipt or personal notification of the candidates. Following the procedure, if the final approved list, duly endorsed, contains a number of approved candidates higher than the number of grants to be filled, there is always an internal recruitment reserve, which can be used when there is a need for occupation by withdrawal of the fellow, to be used during the project eligibility.

**Grant contract model and final reports:** Models approved by the Polytechnic Institute of Leiria.

**Information and publicity scheme of the grant financing:** According to the 30<sup>th</sup> article of the Scientific Research Grants Regulation of IPLeiria.
