## Benefits

3.230,21€ - The remuneration is that of the position of the single salary scale equivalent to the salary that was due to the index 195 of the 1st level of the category of Assistant Investigator, as mentioned in Annex I of the ECIC, unless the candidate declared as winner of this contest, having already been hired in public service in this category by another institution, receives a higher remuneration.

## Eligibility criteria

In accordance with Article 16 (3) of the ECIC, the following factors shall be considered and weighted:

A) The quality of the scientific and technical work of the candidates in the last 5 years (QC) -70% being distributed as follows:

i) Scientific production of the applicant in the last five years in the scientific area of the contest or scientific areas considered as related, as described on 1. - 50%:

Books and / or book chapters with ISBN, published in national or international publishers, in the scientific area of the contest or scientific areas considered as related;

Articles in indexed journals Scopus or Web of Science;

Editor or editorial board member of international journals;

Peer reviewer in international indexed journals Scopus or Web of Science;

Intellectual property.

ii) Research activities carried out over the last five years (35%):

Researcher responsible for research projects financed by an external organization, for example: FCT, ANI, European Union (regional, national and international);

Member of research project team financed by an external organization, for example: FCT, ANI, European Union (regional, national and international);

Prizes, scholarships and other distinctions;

Providing services within the scope of research, financed by an external organization

Participation in evaluation panels of R & D Projects.

Participation in national and/or international scientific networks in the scientific area of the contest or scientific areas considered as related.

iii) Work plan and scientific development aligned with the mission of the School of Health Sciences, for the next 5 years - 15%:

The candidate's ability to have in the future a very relevant scientific production based on the mission of the School of Health Sciences will be evaluated.

B) Contributions in teaching and scientific orientation activities and participation in academic juries (OC) - 10%:

Orientation of completed masters and doctoral students;

Participation in a master's and doctoral jury as examiner;

Participation in a master's and doctoral jury as president;

Participation in selection boards for the hiring of research fellows;

Teaching in master's and doctoral programs.

C) Provision of technical and scientific community service (CSP) - 20%:

Extension and knowledge dissemination activities duly proven by a suitable entity;

Participation in organizing committees of national and international scientific events;

Participation in committees of national and international scientific events;

Participation in scientific events (moderator, chair, guest speaker, etc.);

Participation in activities of dissemination and dissemination of science.

## Selection process

Assessment of curriculum vitae (CV);

Scientific work of candidates;

# Specific Requirements

Those defined in article 10 of the ECIC and taking into account the scientific areas and related scientific areas considered by the Scientific and Technical Council, can only be admitted to it: Individuals who hold a doctoral degree in the scientific area of the contest or similar scientific areas and whose curriculum vitae is in line with the mission of the School of Health Sciences and those who, although of diverse area, have a scientific curriculum whose merit the jury considers to be level compatible with the scientific area of the competition and which are aligned with the mission of School of Health Sciences. If the doctorate has been conferred by a foreign higher education institution, it must comply with the provisions of Decree-Law no. 66/2018, of August 16.

Assistants Investigators from another institution, from the scientific area of the contest or scientific areas considered by the Technical-Scientific Council as related, and those who, although of diverse area, have a scientific curriculum whose merit the jury considers to be level compatible with the scientific area of the competition and which are aligned with the mission of the School of Health Sciences.

The admission of the candidates is conditioned to their approval in absolute merit which will depend on:

1. the publication of at least 5 scientific articles, in a Scopus indexed journal or Web of Science or have obtained a total of, at least, 50 citations in a Scopus indexed journal or Web of Science in the last 5 years.
2. Participation in at least one research project as part of a team in the scientific area of the contest or scientific areas considered by the Technical-Scientific Council as related, funded by national or international agencies.
