- d) Supervising the research work developed by grant holders, research interns and research assistants and participating in their training;
- e) Guide and participate in the institution's training programs.

Eligibility criteria

Under the terms of Article 16, paragraph 3, of ECIC, will be considered and weighted the following factors will be considered and weighted:

A) The quality of the candidates' scientific and technical work (QC) - 60 % being distributed as follows:

(i) Scientific production of the candidate in the area of design, in the specialty of Health and Welfare - 50%:

Books and/or book chapters with ISBN;

Articles in journals indexed Scopus or Web of Science;

Other publications of technical-scientific character (in conference proceedings, oral or poster presentations, or posted, and the like);

Articles in non-indexed journals with peer review;

Editor or member of the editorial board of international journals;

Peer reviewer in international journals;

Registration of industrial property;

Curatorships, participation by invitation in international or national contests or exhibitions;

ii) Evaluation of the research activities carried out (20%):

Principal Investigator of research projects funded by external entity, e.g. FCT, ANI, European Union (regional, national and international);

Team member of externally funded research projects, e.g: FCT, ANI, European Union (regional, national and international);

Prizes, scholarships and other distinctions;

Externally funded research services, e.g.: FCT, ANI, European Union (regional, national and international):

FCT, ANI, European Union;

Participation in Project evaluation panels;

iii) Scientific work and development plan aligned to LIDA's mission, for the next 5 years - 30%:

The candidate's ability to have in the future a highly relevant scientific production will be evaluated, based on LIDA's mission.

B) Contributions in teaching and scientific orientation activities and participation in academic juries (OC) - 10%:

Orientation of master's and doctoral students;

Participation in jury of master's and doctoral as chairman;
Participation in jury hiring research fellows;

C) Provision of technical and scientific community service (PSC) - 30%:
Extension activities and dissemination of knowledge duly proven;
Participation in organizing committees of national and international scientific events;
Participation in scientific committees of national and international scientific events;
Participation in events of a scientific nature (moderator, chair, guest speaker, etc.);
Participation in activities of diffusion and dissemination of science;
Activities of organization, coordination and curation of events in the area for which the the competition.

Selection process

The candidate selection methods, in accordance with Article 10 of ECIC, will be:

Appreciation of the curriculum vitae;

Evaluation of the candidates' scientific work;

The assessment mentioned in items A), B), and C) may be supplemented by an interview with the candidates, whenever the selection board so decides. The interview is not a selection method and is not graded. It aims at obtaining clarification or explanation of elements contained in the candidates' resumes.

Specific Requirements

Individuals who hold a doctoral degree in the scientific area of design, in the specialty of Health and Welfare or, also, those who, although holding a PhD in a different area, have a relevant scientific résumé in the scientific area of Design, in the specialty of Health and Welfare and whose CV is aligned with LIDA's mission.

If the doctorate has been conferred by a foreign higher education institution, it must comply with the provisions of Decree Law No. 66/2018, of August 16, and any formalities established therein must be fulfilled by the date of admission.

Auxiliary researchers from another institution, within in the scientific area of the competition, and those who, although from a different area, have a relevant scientific curriculum in that area.

The admission of candidates is conditional on their approval on absolute merit which will depend on:

- i) Being the author or co-author of at least 5 articles and/or book chapters in the scientific area
- (i) Being the author or co-author of at least 5 articles and/or book chapters in the scientific area for which the competition is open, submitted to peer review, indexed in SCOPUS and/or in databases recognized in the field and/or published by prestigious international publishers and/or in international conference proceedings, within the last 5 years; or
- ii) To have a portfolio demonstrating a relevant production in the scientific area for which the competition is open, in the last 5 years, with demonstration of its effective reverberation and impact for the academy, including the following items: a) description and presentation of the main projects carried out; b) curatorships, participations by invitation in international or national competitions or exhibitions; c) prizes and other national and international distinctions (namely publications or references about the projects carried out); d) specific relevant publications in the field of design such as exhibition catalogs and/or other pieces exemplifying the action as a designer; or
- iii) to have obtained a total of at least 25 citations (excluding self-citations) to scientific works produced in the scientific area for which the competition is open, in the last 5 years;

Applicants must provide proof that they meet the requirements expressed above, indicating the key to be used in the SCOPUS search or other databases that prove it, or including in their CV a listing of the same database that confirms it.

Failure to comply with these requirements will result in exclusion from the application. False statements made by candidates will be punished in accordance with the law.
